on deputation basis – reg.


Applications are invited from the eligible candidates of Central Government/State Government/Courts with requisite qualifications and experience for filling up the following existing vacancies on deputation basis:

1. Assistant (Group 'B' Non-Gazetted ) - One post
2. Recovery Inspector (Group 'B' Non-Gazetted ) - One post.

The selected candidates will be on deputation basis for a period of three years. The period on deputation including the period of deputation in another ex-cadre post held immediately preceding the appointment in the same or some other department/Organization of Central Government should ordinarily not exceed 3 years. The appointment on deputation basis will be governed by the terms and conditions contained in the DOPT OM No.6/8/2009-Estt (Pay-II) dated 17.06.2010 as amended from time to time. The maximum age limit will be 56 years on the closing date of receipt of application.

The requisite qualifications/experience/service, conditions for these posts are given in Annexure-I

Application of the willing and eligible candidates in the prescribed format as per Annexure-II, may be forwarded to the undersigned through proper channel along with attested copies of last 5 years ACRs/APARs and vigilance clearance certificate **on or before 28.5.2018**.
