**1. Section Officer (Group 'B' Gazetted ) - One post**

The selected candidate will be on deputation basis for a period of three years. The period on deputation including the period of deputation in another ex-cadre post held immediately preceding the appointment in the same or some other department/Organization of Central Government should ordinarily not exceed 3 years. The appointment on deputation basis will be governed by the terms and conditions contained in the DOPT OM No.6/8/2009-Estt (Pay-II) dated 17.06.2010 as amended from time to time. The maximum age limit will be 56 years on the closing date of receipt of application.
